# MUCKAMORE ABBEY HOSPITAL INQUIRY WITNESS STATEMENT

I, Pat Cullen, make the following statement for the purpose of the Muckamore Abbey Hospital (MAH) Inquiry. This is my second statement to the Inquiry having previously provided a statement to the Inquiry dated 24 April 2024 (MAHI – STM – 246 - 1).

- 1. Following on from my first statement that I gave to the Inquiry dated 24 April 2024, I would like to provide an addendum to my statement.
- 2. I am no longer employed by the Royal College of Nursing (RCN) having left my position of General Secretary and Chief Executive on 29 May 2024.
- 3. I have however been provided with a letter from the Public Health Agency (PHA) to the Inquiry dated 18 September 2024 and an email referred therein from Alastair Ross in the PHA dated the 15 March 2024. I attach both of these documents to this statement as Exhibit 1.
- 4. I have no recollection of having received the email from Alastair Ross, at the time of making my statement, my office methodically checked my emails and could not locate any email reply from the PHA. The confusion may be that the email response did not come from Aidan Dawson (whom I addressed my email correspondence to) but in fact Alastair Ross.
- 5. I have contacted the RCN to see if they can check my emails. However my understanding is my email account is now closed. I have not received final confirmation as yet from the RCN.
